- d. SKIBOTN: SLEET SHOWERS 1.6 MM. GENTLE BREEZE 4 M/S FROM WEST TO SOUTHWEST.
DAYTIME TEMPERATURE: 4 °C
NIGHTTIME TEMPERATURE: 0 °C

- a. NORTH TROMS: LEVEL TWO (MODERATE)
